## **Checking in and out of Extended Care:**

<u>Students will be scanned into Extended Care by their school ID cards or by our school ID book.</u> Billing will be done through Facts.

## **Extended Care Hours and Rates:**

Hours: 7:30 a.m. to 8:00 a.m. 3:30 p.m. to 6:00 p.m.

#### **Rates:**

Charged at 15-minute increments at \$1.75. 30 minutes \$3.50. 60 minutes \$7.00.

## **Non-School Days and Half-Day Rates and Guidelines**

HALF-DAYS \$25/day – 12:30 to 6:00 p.m.

#### FULL DAYS \$35/day - 7:30 a.m. to 6:00 p.m. \$25/day - for under 5 hours

All non-school days will be subject to closure if we do not have a minimum number of students. A <u>minimum</u> of 8 students will be needed to have the extended care facility open.

Non-school day sign-ups, opening, and closure information will be advertised in the Extended Care room and the Charger Weekly email.
